## Entity Types & Tax Filing Forms

### Brief descriptions

**Sole proprietorships** – Schedule C (Profit and Loss from Business) to be filed along with the individual's 1040 Tax form.

**Single-member LLCs** (Limited Liability Companies) – **IRS form Schedule C**. A Single-member LLC is considered to be a Disregarded Entity which allows the owner / member to file a simple Schedule C (Profit & Loss from business) along with his/her tax return.

**Multi-member LLCs** – IRS form 1065. A Multi-member LLC is treated as a partnership by IRS rules and regulations. See below!

**Partnerships** – IRS form 1065. Form 1065 is used to report the income of every domestic partnership (syndicates, groups, pools, joint ventures, etc. and every foreign partnership doing business in the U.S. or receiving income from U.S. sources).

**S Corps** (Sub-chapter S) – IRS form 1120S

**C Corporations** – IRS form 1120

**NPOs or Exempt Organizations** – IRS form 990. This form is filed by tax-exempt organizations, nonexempt charitable trusts, and section 527 political organizations to provide the IRS with information about the entity's business activities.
